APPLICATIONS

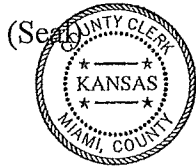

REPORTS FROM STAFF, COMMITTEES, OFFICERS




ADJOURNMENT
