#### CALL TO ORDER

Chairman Dixon called the meeting to order at 1:00 p.m.

### **CONSENT AGENDA**

Commissioner Roberts moved to approve the Consent Agenda, with two additions, as follows:

Commissioner Pretz seconded; the vote was unanimous.

### **NEW BUSINESS**

Kristie Reitinger, of Road & Bridge, requested the board to consider authorizing Commission Chair to execute Notice to Proceed to Superior Bowen Asphalt Company, LLC for Project 18-16-CO (666), asphalt overlays, in the amount of \$1,252,245.80. She explained the project start date will be August 8, 2019 and will last approximately 20 working days, ending on September 5, 2019. Commissioner Roberts moved to approve the request and Commissioner Gallagher seconded; the vote was unanimous.

Commissioner Pretz moved to nominate Commissioner Rob Roberts as voting delegate and Commissioner Danny Gallagher and Commissioner Pretz as the two alternate voting delegates for the Kansas Association of Counties annual meeting, November 13, 2019. Commissioner Vaughan seconded the motion and the vote was unanimous.

Steve Lyman, Finance Director, requested the board to consider the approval of the publication of the notice of budget hearings for 2020 operating budgets for Miami County, Bucyrus Lights and Sirens, Hillsdale Lights and Sirens, Fire District No. 1, and Fire District No. 2. The publication date will be July 24, 2019 and the hearing date will

be August 7, 2019. Commissioner Gallagher moved to approve the publication and Commissioner Pretz seconded; the vote was unanimous.

Steven Lyman, Finance Director, requested the board consider the update regarding personnel changes for the bank account signature cards. The changes will consist of removing Steve Lyman, Changing Tiffany Taylor's job title, and adding Kristy Hill and Patty Sanders. Commissioner Pretz moved to approve the update and Commissioner Vaughan seconded; the vote was unanimous.
