## THE MINUTES OF THE REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF MIAMI COUNTY, KANSAS

The Board of Miami County Commissioners met in regular session, in the Commissioners' Meeting Room, Miami County Administration Building, Paola, Kansas, on August 8, 2018. Those present were:

### CALL TO ORDER

Chairman Dixon called the meeting to order at 1:00 p.m.

#### **CONSENT AGENDA**

Commissioner Roberts moved to approve the Consent Agenda as follows:

Commissioner Gallagher seconded; the vote was unanimous.

#### **CITIZEN COMMENT**

Cliff Blackmore, of Paola, complimented County Clerk Janet White and her staff on the professionalism of conducting the 2018 Primary Election.

Ernie Scherman, of Paola, requested the board consider his area of Osawatomie Road to be considered for the 2019 chip & seal project.

#### **NEW BUSINESS**

Chairman Dixon opened the floor for a public hearing to amend the 2018 budgets for the Miami County Fire District No. 1 Equipment Fund 417, Miami County Solid Waste Fund 207, and the Detention Center Sales Tax Fund 924, at 1:15 p.m. With no comments, Chairman Dixon closed the public hearing at 1:16 p.m.

Steve Lyman, Fiscal Services Manager, requested the board to consider adopting the 2018 amended budgets for Miami Fire District #1 Equipment Fund 417, Miami County Solid Waste Fund 207, and the Detention Center Sales Tax Fund 924. Commissioner Pretz moved to approve the amended budgets and Commissioner Gallagher seconded; the vote was unanimous.

Steve Lyman, Fiscal Services Manager, requested the board consider adopting resolutions for Miami County Fire District No. 1 (R18-08-028) and Hillsdale Lights & Sirens (R18-08-029) as the 2019 proposed operating budgets exceed the 2018 budget as adjusted to reflect changes in the Consumer Price Index for All Urban Consumers for calendar year 2017. Commissioner Pretz moved to approve the resolutions and Commissioner Stiles seconded; the vote was unanimous.

Chairman Dixon opened the floor for a public hearing for the 2019 operating budget: Miami County, Miami County Fire District No. 1, Miami County Fire District NO. 2, Bucyrus Lights & Sirens, and Hillsdale Lights & Sirens, at 1:19 p.m. With no comments, Chairman Dixon closed the public hearing at 1:19 p.m.

Steve Lyman, Fiscal Services Manager, requested the board to consider adopting the 2019 Operating Budgets for: Miami County, Miami County Fire District No. 1, Miami County Fire District No. 2, Bucyrus Lights & Sirens, and Hillsdale Lights & Sirens. Commissioner Gallagher moved to approve the budgets and Commissioner Roberts seconded; the vote was unanimous.

Commissioner Pretz thanked Mr. Lyman, the budget team, Department Heads, and the Miami County tax payers.

J.R. McMahon, Director of Public Works Road & Bridge, requested the board to consider the three-year purchase agreement (A18-08-011) with Cartegraph Solutions for training, support, and releases of upgrades regarding signs, pavement, and bridges. The 2018 cost is \$17,690.50 with a yearly cost of \$7,729.84. Commissioner Roberts moved to approve the agreement and Commissioner Pretz seconded; the vote was unanimous.

Matthew Oehlert, Miami County Project Manager, requested the board to consider the approval of a request to solicit bids for the Administration Building sidewalk, mid-street crossing, and the courthouse parking lot. Commissioner Roberts moved to approve the request and Commissioner Pretz seconded; the vote was unanimous.

Matthew Oehlert, Miami County Project Manager, requested the board to consider the approval of a notice of bid award to PbX Corporation for bridges FAS 589 and FAS 590,

located at Old Kansas City Road, south of 255<sup>th</sup> Street, Polymer Overlay Projects. Commissioner Stiles moved to approve the request and Commissioner Gallagher seconded; the vote was unanimous.

Cathy Cooper, Director of Community Corrections, requested the board to consider the approval of the Sixth Judicial District Community Corrections – Juvenile Services 2018 Quarterly Budget Adjustment. Commissioner Stiles moved to approve the budget adjustment and Commissioner Stiles seconded; the vote was unanimous.

Chairman Dixon moved to approve the submittal into the K.A.C. 2019 Legislative Platform concerning binary explosives, commonly referred to as "Tannerite". Commissioner Stiles seconded the motion and the vote was unanimous.

J.R. McMahon, Director of Public Works Road & Bridge, stated he will attend a meeting, tomorrow, regarding the two-miles of Metcalf Road that the County maintains inside of the Louisburg City Limits and the grant approval.
