Janet White, Miami County Clerk, informed the board the 2018 Primary Election has been concluded. The Official Results have been posted on the County Website.

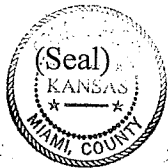
**PRESENTATIONS BY MEMBERS OF THE COMMISSION**


**ADJOURNMENT**
